The Graduate Council met eleven times during the period of September 2020 through June 2021. Complete records of Council activity are on file in the Office of the Academic Senate.

The Courses and Programs Subcommittee made recommendations and the Council acted on 127 courses: 42 new courses, 70 changed courses, and 15 deleted courses.

The Graduate Council Fellowship Subcommittee met five times to evaluate the following:

- 1) Dissertation/Master's Thesis Research grant applications. The subcommittee reviewed 16 Dissertation and Master's Thesis Research Grant and awarded 15 amounting to \$16,205.73.
- 2) Earle C. Anthony Travel award applications were not awarded due to COVID-19.
- 3) The Fellowship subcommittee reviewed applications and provided rankings to the Graduate Division Dean for the following:
 - a) Graduate Division Graduate Research Mentorship Program (GRMP) – 3 applications
 - b) Dissertation-Year Programs (DYP) Fellowship Program – 32 applications

Four competitive DYPs were awarded, 3 of them were allocated as DYFAs. 2 GRMPs were awarded. DYPs and GRMPs awards amounted to \$1,238,068.

- 4) The Fellowship subcommittee reviewed 7 nominees for the 2021 Doctoral Dissertation Advisor/Mentoring Award and selected one recipient, Professor of Computer Science & Engineering and Electrical & Computer Engineering, Nael Abu-Ghazaleh.

The Graduate Council concluded its regularly scheduled reviews of the Biomedical Sciences, CMDB, GGB, Management PhD, Religious Studies, Southeast Asian Studies, and Spanish graduate programs as well as an internal review of the Sociology graduate program.

Graduate Council discussed the program responses, corresponded with, and voted to close out three of the reviews conducted in 2020/21 for the following graduate programs: Religious Studies, Southeast Asian Studies, and Spanish. Graduate Council discussed the program responses, corresponded with, and voted to close out two of the reviews conducted in 2019/20 for the following graduate programs: Environmental Sciences & Entomology. Graduate Council discussed previous responses from the 2018/19 review of the PMBA program and replied to the program's most recent response in an effort to close-out the remaining SSP reviews from AY 2018/19.

Graduate Council hosted one Graduate Program Review Preparation meeting via Zoom in the spring of 2021 to prepare the programs scheduled for review in 2021/22 for the review process.

Additionally, the following actions were taken by the Graduate Council during 2020/21:

- At its first meeting of the academic year, the Council adopted a statement regarding possible conflicts of interest by its members. (Sept. 2020).
- Emergency temporary Graduate Regulation changes due to COVID-19.

- Reviewed and ruled on one confidential graduate student grade appeal.
- Reviewed several GRE rubrics and decided to grant programs a one-year temporary extension to waive the GRE. An ad hoc committee is being formed by the Senate to review, provide feedback, and approve all GRE rubrics to be used on a permanent basis.
- Non-Senate Participation on Oral Qualifying Exam, Dissertation and Thesis Committees.
- Proposed Changes to Graduate Regulations 4, 4.5, and 4.6.
- Proposed Changes to Graduate Student Academic Appeals Procedures.
- Provided feedback on the Graduate Student Survey.
- Reviewed request from Computer Science to be allowed to use non-academic letter writers for admission to their MS program.
- Reviewed and provided feedback on the Graduate Finances Working Group Report.
