# [Systemwide Review] Proposed Revisions to APM - 015/016 and Disciplinary Sanction Guidelines for Misconduct Related to Expressive Activity and Guidelines re Good Cause Extension Factors

CoC discussed the proposed revisions and members were apprehensive about centralizing faculty discipline and believe this is not the best idea. It was not clear from the proposal the justification for this change. Members would like clarification on the inconsistencies in the proposal between calendar days and business days, and if the 14-day deadline to form a hearing panel makes allowances for breaks (between quarters/semesters, holiday, and summer). Members felt strongly that using business days would be more appropriate and the 14-day deadline should only be in effect during the quarter/semester.
