Dear Jim,

Relevant committees from the UCR Division of the Academic Senate, along with its Executive Council, discussed the Proposed Revisions. The reviewing Senate committees were the Committee on Academic Personnel, the Committee on Diversity and Equal Opportunity, the Committee on Research, Committee on Faculty Welfare, and the Executive Committees of the College of Humanities, Arts, and Social Sciences, the Graduate School of Education, School of Medicine, and School of Public Policy. All endorse the proposed revisions with no negative votes.

Executive Council engaged in rigorous discussion regarding the proposed revisions. It was shared that a concern was raised at the last UCPB meeting that these revisions potentially require significantly more of LSOE's than fulfilling teaching responsibilities. Some on Council indicated that the revisions did define requirements for LSOE's in a more comprehensive and reasonable manner. Concern was expressed that some departments might interpret LSOE appointments as a "backdoor" method to obtain a ladder-rank faculty appointment.

Additionally, there was significant discussion in Executive Council that the UC system, as marked by the establishment and expansion of this title, could be undermining its own profile and mission as a research institution. Members of Council suggested that there be a cap placed on the amount of LSOE's appointed systemwide and/or at each campus. This could be a hard number or a percentage.

Members of Council also suggested that there be an LSOE Committee on Academic Personnel (CAP) that reviews LSOE personnel files. A faculty welfare concern was expressed that recent PhD graduates hired under this title will have diminished research pursing this teaching and service career trajectory. This item appeared to some as UC attempting to avoid unionization and actualize salary savings at the expense of the University's research reputation, although LSOE's don't cost much less than ladder rank faculty. Discussion was also had regarding the fact that "influence" as mentioned in the policy is a broad requirement.

Further, Council agreed that this is an issue to which the Senate must pay close attention. This title should not mark a move to abandon the mission of UC as a research institution and this may become a

wedge issue. The title "Professor of..." would be used for an appointee's public profile and this could be misleading. Finally, it was mentioned that a proliferation of LSOE's would have an impact on grant dollars awarded to UCR.
