Re: Request for Senate Consultation on the Draft WSCUC Special Visit Report

Dear Ken,

I write to provide consultative Academic Senate feedback regarding the *Draft WSCUC Special Visit Report*. As always as part of our shared governance partnership, I encourage the Administration's careful reading of the deliberate comments provided by each of the responding committees whose memos are attached, as well as those in this memo from Executive Council who discussed the draft report on November 8, 2021.

To be clear, the Senate was asked to comment on this draft report and not assess and/or agree to a new way forward with the educational approach and mission on our campus. The draft report sets in place an educational approach and mission that utilizes Key Performance Indicators (KPI's) that has not been presented as such nor consulted on with UC Riverside faculty.

Members of Council expressed serious concern regarding aspects of this report which establish concepts and directions on assessment that have not had much vetting by faculty. The emergence of Key Performance Indicators (KPIs) requires a clear, strong, and pedagogically based case that must be made to campus for its use. Members were uncomfortable with what may be an increasing notion that educational assessment is simply checking boxes that require fitting UCR - and UC campuses system wide - into a one-size fits all approach for accreditation. While these may be the expectations of accreditation bodies, some members felt it is the responsibility of UCR to press why our campus, which is celebrated for doing things differently to meet the needs and challenges of our student demographic, is simultaneously being asked to simply fall in line with what appears to be a checklist approach to educational expectations. Accepting KPIs to accommodate the accreditation process is a short-term solution which can have potentially larger and unintended negative impact down the line for UCR faculty and students.

Please provide definitions of KPI and provide contextual information that affirms their use at UCR.

Further discussion around KPIs and other related assessment changes should be presented to relevant committees such as, and not limited to, the Committee on Educational Policy and the Graduate Council for more direct consultation and specific informing of the future directions and implementations of assessment improvements.

Finally, it was suggested that it will be important to have the Office of Evaluation and Assessment and Associate Provost provide a plan for campus goals around assessment that accomplishes the quantitative goals of tracking student progress to degree and to learning goals.

#### Dear Jason:

As you know, when UCR last reaffirmed our accreditation in 2018 with the Western Association of Schools and Colleges: Senior College and University Commission (WSCUC), the commission requested a Special Visit in 2022 to follow up on issues that were identified during the 2018 reaffirmation visit. In preparation for the visit, WSCUC also requested that UCR prepare a report that addresses the issues. A draft of this report is now complete (attached and also available <a href="here">here</a>), and has already been reviewed by members of the Assessment Advisory Committee and both the chancellor's and provost's cabinets.

The report must be submitted to WSCUC by December 2, 2021. I would be grateful if the Senate could provide consultative feedback on the draft by November 5, 2021.

There are multiple audiences for this document: (1) the visiting team, (2) the campus community, and (3) the public at-large. I would appreciate the Senate's help in ensuring we have our facts correct and complete, and that we are presenting our story appropriately for these audiences. The visiting team will be particularly interested in assessing how responsive we have been to the four issues in section 3 of the report. They also will be looking for evidence to support our assertions, so if evidence is lacking in any areas, please call attention to it and/or point us towards supporting documents.

Also note that the report must follow the organization that has been used in the

draft, and all statistics will be updated to official fall 2021 numbers when available and before submitting to WSCUC.

Dear Jason,

The SOM Faculty Executive Committee has reviewed the Draft WSCUC Special Visit Report and commends the authors on the considerable effort made in highlighting the changes at UCR since the last WSUSC visit. The report clearly identifies the specific criticisms/concerns raised by WSCUC in 2018, and the measures taken or in development, to address these issues. The efforts made to improve the campus culture regarding accreditation bodies, and availing of the existing expertise on campus within individual units – such as SOM and BCOE – who have significant experience in dealing with national accrediting bodies, is a positive move. It is clear that the decentralized budget model has been a failure with respect to stabilizing campus finances and providing resources to support cross-unit enterprise. The need for ongoing clarity in explaining campus finances, and the implications of amendments to the budget model, are of paramount importance to restore confidence in the viability of campus programs. The report does a good job of identifying and describing these budgetary issues.

We suggest incorporating the revised text for procedural accuracy in section 10 (School of Medicine under-capitalization) on page 26 of the document:

1. **Original text** (paragraph 2, line 6) - The FY22 state budget allocated \$25M in one-time funding which will stabilize the clinical enterprise and result in a self-sufficient, sustainable operation that is aligned with the SOM mission by 2025.

**Revised text** –The State Budget Act of 2021 allocated \$25M in one-time funding in FY22 to help stabilize the clinical enterprise and move toward a self-sufficient sustainable operation that is aligned with the SOM mission, by 2025.

2. **Original text** (paragraph 3, line 2) - In FY20, the State approved \$100M for the construction of a new 90,000 square-foot SOM academic facility.

**Revised text** - In the State Budget Act of 2019, the State approved \$100M in FY20 for the construction of a new 90,000 square-foot SOM academic facility".
