Dear Michalis,

Currently, there is only one Division at UCR that the Senate recognizes as an academic unit: the Division of Undergraduate Education.

No other Division is qualifies: Graduate Division is not an academic unit, it is solely an administrative unit. The various divisions within CNAS and SOM are subunits under the recognized unit, CNAS and SOM, respectively, and are not recognized as a separate academic unit.

The reference to "divisions" in the Courses bylaw change proposal is misleading, although I can see that it can look awkward to write "colleges/schools/division". In said proposal, there are 8 "colleges/schools/divisions" at UCR: CHASS, CNAS, BCOE, SOM, SPP, SOE, BUS, and DUE.

## Sang-Hee,

The CoC has a question and maybe you can help us: what is the definition of Division and as a result how many Divisions do we want to consider as separate "units" that need representation within UCR? It may be helpful to create a list of all such Divisions.

The context: There was a proposal to add "divisions" as units that need to be represented in the selection of C . on Courses by laws.
Although CoC does not see its jurisdiction to second guess by laws of other committees, we wanted a clarification and potentially the CoCourses and other Committees to be aware of the potential consequences in filling the
committee timely.

The tradeoff is obvious:
a. Representation of Divisions increases inclusivity and diversity in some sense at least but it can hurt it in others
b. Filling positions becomes more complex optimization problem
E.g. In filling an empty spot, a diversity person is in a different Dept but same Division as an existing member of a committee.

Here the need to not have people from the same Division can hurt diversity.
