Re: [Campus Review] Proposed Changes to the College of Humanities, Arts, and Social Sciences Bylaws (Bylaw 4.1.1.1)

The Committee on Rules and Jurisdiction has carefully considered the Proposed Changes to the College of Humanities, Arts, and Social Sciences Bylaws (Bylaw 4.1.1.1). The Committee appreciates that the proposed changes are meant to update the name of a changed department.

Nevertheless, R&J believes the proposed regulations would benefit from modest modifications to increase clarity and consistency before approval. The Committee on Rules and Jurisdiction offers the following comments to assist in the above and to ensure overall document consistency:

- 1) Correct the listings of two departments whose names have also changed (the Department of the History of Art, and the Department of Comparative Literature and Languages)
- 2) Review why faculty from three departments in CHASS (Black Study; Media and Cultural Studies; and Society, Environment, and Health Equity) are apparently excluded from membership on the College Executive Committee, according to this proposed regulation, and make any necessary corrections.
