

Re: Process involving students at UCR who need access to placement tests over AY 20-21

The Riverside campus expects incoming students to take the Systemwide AWPE that will be offered online on June 20th. For those students who need to know their placement in order to register for classes with an advisor in early July, we are offering an earlier June exam that will be processed in time for them to sign up for the proper writing course in the Fall. Students who take neither the early UCR exam nor the Systemwide exam will be notified that they have half a dozen more opportunities to test later in the summer. Most of the UCR administrations are scheduled around summer orientations, for the convenience of students. (Of course, students can take the AWPE only once.)

All of the local administrations are committee-graded, and the process closely follows best practices of the system-wide administration. Led by one of the Assistant Chief Readers of the Systemwide AWPE, the committee charged with local scoring and placement is comprised of UCR's most senior lecturers, most of whom have, for many years, served as readers for the Systemwide AWPE. The local AWPEs will be scored and placed in a timely manner to accommodate students' online orientations with their advisors. Judging by the many years these procedures have been used, the process should be seamless.

Those students who do not satisfy ELWR or take an AWPE once fall quarter begins have the option to enroll in English 4 without testing. Make-up AWPEs are offered during fall and winter quarters to the relatively few students who did not satisfy ELWR and did not take an AWPE or enroll in English 4.
